Continuing 1¢ city sales tax good for growth

A group called Citizens for Property Tax Relief has sponsored an amendment that will extend Minot's 1 cent sales tax. The sales tax was originally established to fund the Northwest Area Water Supply (NAWS), but city finance director, Cindy Hemphill, has indicated that NAWS will have sufficient funding by the end of this year, which means the sales tax could be discontinued.

Rather than lose the sales tax revenue, supporters are hoping to provide direct property tax relief, fund infrastructure and facility needs in the city of Minot and avoid new taxes by continuing the 1 cent sales tax. According to the amendment proposed, 40 percent of the tax revenue would go to city infrastructure, 30 percent to direct property tax relief, and 30 percent to community facilities.

"The Minot area is growing in leaps and bounds, and we need to ensure that our infrastructure can keep up with the opportunities

before us. The 1 cent sales tax does that," said John MacMartin, president of the Minot Area Chamber of Commerce. "In addition, we will share the cost of our facilities with those using them and we get some relief on our property taxes."

The tax will provide \$2.5 million in direct property tax relief. For every \$100,000 assessed valuation of a home, homeowners will receive property tax relief of \$100 each year. "That kind of break helps all of us, but it can really make a difference to those on fixed incomes," MacMartin added.

If the amendment passes, the current sales tax would remain level and stay in place for

Minot is growing and without the continuation of the sales tax, Minot is impacted. Property taxes at the current levels cannot absorb all the costs of the city capital improvement projects. Without the continuation of the 1 cent sales tax funding options are narrowed to increasing property taxes or utility costs for the residents of Minot.

According to MacMartin, NAWS is protected by the amendment. Should the city finance director determine that additional funding is necessary to fund the city's share of the current NAWS project, the funds for each of three (infrastructure, property tax relief and community facilities) would be reduced in order to provide the funds necessary to complete the NAWS project.

The amendment will be on the June 14 ballot and the Chamber of Commerce Board of Directors has gone on record in support of the proposed amendment.



ND State Fair sets ticket sale record for rock concert

The North Dakota State Fair experienced record sales volume of a rock concert for the first day of Kid Rock ticket sales. The Grandstand Showpass opening ticket sales day on March 16, 2011 serves as the highest opening day of ticket sales in State Fair history.

Jewelry exhibit set for Northwest Art Center

Minot State University art students Kayla Cote and Erika Edwards will present their joint senior capstone exhibition, "Diamond in the Rough," May 5 through June 1, 2011 in the Gordon B. Olson Library Gallery, MSU. Opening reception is Tuesday, May 10 from 6:30 to 8 p.m. at the library gallery. The exhibition will feature unique jewelry techniques as well as creative display designs.

Cote is a graphic design major at MSU who was inspired to make jewelry after an introduction to the craft in one of her university art classes. Cote uses found objects, "up-cycling" them into her jewelry creations. Many of her pieces contain fragments of vintage jewelry.

Edwards' pieces incorporate bead weaving and bead embroidery techniques using seed beads, gemstones, glass beads, and found objects such as vintage brooches. Her work is hand stitched, and one piece can take as much as 30 hours to complete. Her work includes practical pieces as well as wearable art.

The exhibit and reception are free and open to the public. Parking on the MSU campus is unrestricted after 5 p.m.

New air conditioning rebates available
