Vote Yes April 21 to support quality of life and lower property taxes in Minot

The recently formed Citizens for Minot's Future group is placing its support behind the proposed Minot Aquatics and R e c r e a t i o n Center (MARC) and urges a yes

vote on April 21. The group has representatives from all walks of life and is excited to see a project that will improve the quality of life in Minot, offer amenities that do not exist elsewhere in town, and provide property tax relief in the Magic City.

At a press conference in March, Tawnya Bernsdorf, chair of the Citizens for Minot's Future group said, "We are excited as a group of Minot residents to be able to support a project that our community has been asking for over the past 10 years. The MARC is a real chance to define who we are as a community, in a positive, forward-thinking way that embraces healthy decisions, attracts families and serves the needs of our broader community."

The vote on April 21 would give the Minot Park District a one-cent citywide sales tax, in place of the current property tax, to support its general operations and pay for the bonding associated with building the MARC. For someone with a house valued at \$200,000 in Minot, this represents a \$216.61 annual reduction in property taxes. And for the average property owner, this will lower overall tax burden, as a person with a \$200,000 house would have to spend more than \$21,661 on taxable items in a year to increase their bottom-line tax burden.



The citizens committee is excited about the many options that this center would place under one roof. An accessible aquatics and recreation center will be great for existing individuals and families, as well as an attractive piece for businesses to use in recruiting new staff to our growing community. The group feels that the MARC will add to a sense of community pride.

The Citizens for Minot's Future supports the Park District's proposal to have certain features of the MARC available to the public at no cost, including the seniors lounge, an indoor accessible playground, and the large indoor track.

The Board of Directors of the Minot Area Chamber of Commerce urges a yes vote April 21 to support a higher quality of life in the Minot region and to lower property taxes.

AARP and SB sponsor workshop in Minot which focuses on aspiring entrepreneurs 50+

AARP and the U.S. Small Business Administration (SBA) will present a workshop in Minot to help individuals ages 50 and older thinking about starting their own business.

Contrary to popular perception, entrepreneurship is not exclusive to the young. The Kauffman Foundation reports the 55- to 64year-old age group represented almost onequarter of new businesses started in 2013, compared to just 14 percent in 1996. Kauffman reports that Americans in the 55-64 age group started new businesses at a higher rate than those in their twenties and thirties every year from 1996 to 2013.

The two-hour workshop begins at 11:30 a.m. Tuesday, April 14, at Town and Country Credit Union. The purpose of the event is to match these "encore entrepreneurs" with successful business owners and community leaders for advice and assistance. Panelists from a variety of backgrounds will share their stories and insights on starting a business later in life.

Those attending will receive information on the basics of starting a business as well as programs and resources available through SBA and AARP. Participants will have the opportunity to meet one-on-one with a representative from SBA or SCORE.

Two MAFB wings earn Omaha Trophy

Congratulations to Minot Air Force Base, as both the 5th Bomb Wing and the 91st Missile Wing were named recipients of the 2014 Omaha Trophy.

Minot's Warbirds were named the 2014 Omaha Trophy recipient for the fourth time as the command's premier strategic aircraft operations wing, and

The level of sustained mission performance while the 5th Bomb Wing had the runway being rebuilt was pretty outstanding, said Col. Jason Armagost, 5th BW commander.

"I think that contributed greatly to the kind of spectrum of mission accomplished," he added. "Counting operations taking place essentially at actually three different locations at once really allowed leadership to shine at the squadron level and above at the group level. They really tackled the challenges they were faced with and they did it in a very high profile way."

"I think the Omaha Trophy in general is a wonderful accomplishment and a huge testament to everything we accomplished in 2014," said Capt. Margaret Ingerslew, 69th Bomb Squadron radar navigator. "We overcame a lot of obstacles: operating out of Guam as well as Ellsworth Air Force Base in Rapid City, South Dakota, because our runway was closed for the majority of the summer. So, having to pick up and transport everything from Airmen to aircraft to maintenance supplies - that's just a huge feat, and I think we did it relatively seamlessly because the mission went on."

"The big thing is probably it's looked at in its entirety. It's not any singular event, and the Airmen really shined this year," Armagost said.

"It's a fantastic recognition for the Airmen and all of the folks, family and community because really I see it as a very broad level of sustainment of excellence — not just for the mission but for how everything gets done," Armagost said. "It's a 365 kind of award. It's

Save the Date: Business After Hours: May 21 Verendrye Electric Cooperative 1225 Hwy. 2 Bypass East The Omaha Trophy is awarded annually to four outstanding units that represent USSTRATCOM's mission areas, their role in global operations and USSTRATCOM's continued emphasis on strategic deterrence.

The four awards given are the Global Operations, Intercontinental Ballistic Missile, Submarine Ballistic Missile and Strategic Aircraft Operations trophies. Selections are based on formal evaluations, meritorious achievement, safety and factors such as community involvement and humanitarian actions.

When submitting for this award, wings write packages listing all of the attainments across the various categories depicting how they complete the mission and go above and beyond.

This trophy was first awarded in 1970 by the citizens of Omaha, Nebraska, through the Strategic Air Command Consultation Committee, to the most outstanding SAC wing in honor of the 25th anniversary of the SAC.

In an article written by USSTRATCOM honoring all the recipients for this award, U.S. Navy Adm. Cecil D. Haney, USSTRATCOM commander, praised the organizations for demonstrating "the highest standards of performance in support of USSTRATCOM's diverse missions."

not a singular event and it's how we get after our assigned mission here."

The Rough Riders were named the 2014 Omaha Trophy recipient as the command's premier Intercontinental Ballistic Missile wing, in recognition of outstanding support to U.S. Strategic Command's global strategic deterrence mission over the last year.

This is the fifth time the wing has earned the Omaha Trophy and will be added to the 91st MW having earned the coveted Blanchard Trophy from the Air Force Global Strike Challenge along with the other awards last year.

"The Omaha Trophy is the result of unwavering dedication to mission, leadership at all levels, and a reflection of our outstanding Airmen and their families," said Col. Mike Lutton, 91st MW commander. "Teamwork and integration across the wing and the outstanding mission support the Warbirds provided made this happen—Bully."

"The 91st MW won the Omaha Trophy because all Airmen across the board take their jobs very seriously and preform their job at high levels," said Airman 1st Class Robert Cook, 91st Maintenance Operations Squadron mechanical and pneudraulics section technician. "It takes every shop working together fluidly to put ICBMs on alert and we demonstrate this daily."

Members of the 91st MW ensured their teammates were prepared to complete their assigned tasks and knew where they needed improvement.

"I spent half my time as a line crew member pulling about six to eight alerts a month," said Capt. Christopher Hall, 91st Operations Group ICBM combat crew flight commander. "During this time, our focus was doing the operational mission. We participated in tests and exercises and made sure we did it to the best of our abilities."

"It feels great to see all the hard work and dedication pay off. Many of the people in our office worked 12 hours or more on a consistent basis to ensure that we were meeting the mission requirements," he added. "This award validates all that hard work and says that it did not go unnoticed."

Members of one unit that contributed to the wing's victory, the mechanical and pneudraulics section, said their crew was excited to hear the news that Minot had won the Omaha Trophy. It was especially nice to be recognized for all of the long hours and dedication they put into doing everyday maintenance.

Dakota Sauare Mall plans for multi-million dollar renovation to begin in April

Officials with Dakota Square Mall announced a multi-million dollar renovation of the 815,000 square foot regional shopping center. The project is slated to begin in early April and to be completed by mid-November.

Plans call for multiple enhancements, including a new color palette, new flooring, new lighting, and interior finishes of stone and wood. The food court will also be updated with new furniture and seating configurations designed for family and community dining. New soft seating will replace the mall's wooden benches, creating "conversation" areas perfect for relaxing and chatting. New planters and landscape will complement the exterior upgrades.

"We are committed to keeping Dakota Square Mall fresh and vibrant," said Chuck Massey, general manager. "This is an exciting project which underscores our focus on delivering the premiere destination to shop, dine, and enjoy an outing with family and friends."

With the new era of digital diplomacy, the Royal Norwegian Embassy in Washington, D.C., launched the #VirtualAmbassador Program, a new initiative, which enables university students from across the U.S. to interact live with Aas.

"Ambassador Aas will give a brief presentation via Skype, followed by a question-andanswer period by the American students," said Libby Claerbout, director of international program. I also encourage students to participate in a virtual question-and-answer session with the ambassador via his Twitter handle, @kareraas, where their questions are included in the presentation."

The MSU presentation will cover the following topics:

- * "The Arctic" Changes in the Arctic cause unprecedented challenges and emerging opportunities. Arctic ecosystems and human societies will be most strongly affected, but the Arctic environmental changes have global implications as well. Questions posed may include "How should these challenges be handled?" and "Is managing the Arctic a global task or is it solely the responsibility of the Arctic coastal states?"
- "NATO, the U.S. and Norway" NATO constitutes the basis for Norway's security. Norway's relations with the U.S. on security and defense represent the fundamental element of the American membership in the alliance. Within the alliance context, Norway collaborates with the U.S. on a wide variety of issues and activities, at both the policy and operational level, and in terms of procurement. Each entity is faced with current and emerging challenges. The international security pattern is being transformed. Norway also has to adapt and will do so in close cooperation and coordination with allies and partners, in particular the U.S. Norway will continue to play an active part in ensuring that NATO remains a viable, effective and relevant alliance.

Aas, a veteran of Norway's foreign ministry, presented his credentials to President Barack Obama Sept. 17, 2013. The United States is the second ambassadorial posting for Aas, with his first posting to Afghanistan in 2008.
