The community is invited to submit service projects on behalf of civic, religious and non-profit organizations. The organization will be required to supply any necessary supplies and Magic Day of Giving will supply the volunteers. Submitted projects are due Aug. 14, 2015.

The event will kick off Friday, Sept. 11 with a free breakfast from 8:30 to 10 a.m. in Roosevelt Park Zoo where the first 1,000 volunteers to check in will receive a free Magic Day of Giving t-shirt. Volunteer teams will then complete their two hour long proj-

ects throughout the day.

The Social Security Board of Trustees released its annual report on the long-term financial status of the Social Security Trust Funds.

Although by a smaller amount than last year, total asset reserves continued growing in 2014. Overall 2014 net increase was 25.0 billion dollars

as shown in the TRUST FUND FINANCIAL OPERATIONS IN 2014 section of the report. Continued growth is projected through 2019, to end beginning with 2020.

### Community wish list grant opportunity launch Aug. 1

United Community Bank of ND opened up nominations for their new Community Wish List grant opportunity Aug. 1, 2015. The purpose of this program is to support the Burlington, Drake, Leeds and Minot communities and surrounding areas by helping to encourage the growth of community events and project enhancements.

Nominations for community events or projects will be accepted until 5 p.m. on Aug. 31. Following this deadline, three nominees will be chosen and promoted on United Community Bank's Facebook page, giving community members the opportunity to vote for seven days. The organization with the

### Affordable housing developments in need of contributions

The North Dakota Housing Incentive Fund (HIF) is well underway with 24 housing projects given conditional commitments of funds, but contributions from taxpayers are needed to move them forward.

HIF relies on taxpayer support to provide low-cost financing to developers of affordable multi-family housing. The projects, located across the state, will split \$34.7 million leveraging \$181.5 million in development costs and creating 985 housing units of which 285 are targeted to house-holds that provide essential community services. Approximately one-third of the developments will provide housing for special needs households including disabled, homeless and elderly individuals and families.

"We look forward to hearing from more of our

past contributors and encourage new businesses and individuals to support the Housing Incentive Fund so we can get these important projects completed," said Jolene Kline, NDHFA executive director.

NDHFA began accepting contributions into the fund on July 1. In order to be able to honor its financial commitments, the agency must fully capitalize the fund, raising \$30 million by Dec. 31, 2016.

In addition to the \$30 million in tax credit authority given to NDHFA by the state legislature during the 2015 session, the agency also received \$5 million from profits earned by Bank of North Dakota. NDHFA will receive another \$5 million from BND contingent upon the bank earning \$130 million in profits during calendar year 2015.

NDHFA will hold another application round when additional program funding becomes available.

HIF contributions can be targeted to a specific project or designated for general use in a community or region. Individuals and businesses that contribute to HIF receive a dollar-for-dollar state tax credit.

- Advice and assistance in postsecondary course selection and priority registration.
- Information on financial aid programs, benefits and resources for locating public and private scholarships and help in completing financial aid applications.
- Education or counseling services to improve the financial literacy and economic literacy of students, including financial planning for postsecondary education.
- \* Activities designed to assist students in achieving career and academic success.

POWER Center staff members are Major, Tiffany Fylling, advising coordinator, Connie Blair, tutoring and mentoring coordinator, and Keryl Lesmann, program assistant. The POWER Center, as a TRiO-Student Support Services program, strives to increase the retention and graduation of its participants and help students move from one level of higher education to the next.

"Unpredictable North Dakota weather never fails to surprise us, but it didn't stop attendees from enjoying all we had to offer at the 2015 North Dakota State Fair," said ND State Fair General Manager Renae Korslien. "Our 50th anniversary truly was great big fun, and once again, fairgoers left our gates with smiles on their faces."

Korslien was very happy with a strong attendance of 305,093. Slightly lower than last year, rain and predicted storms on several nights affected attendance. Still, she said, the Grandstand entertainers had an impressive effect on attendance: Miranda Lambert, 12,525; Seether, 6,351; Chase Rice, 6,748; Kellie Pickler, 4,766; Kip Moore, 6,062; Keith Urban, 12,992; and Aerosmith, 16,666. Attendance at the Enduro races was 4,140; 2,432 at the NPRA Bull Riding Championships over two nights; and 2,274 at the ranch rodeos.

"There is no way we could accomplish all we do every year without the staff, including both individuals and organizations, who take so much pride in the work they do," said Korslien. "The 2015 North Dakota State Fair has been exceptional. The staff is now looking forward to planning the 2016 ND State Fair, which will be held July 22-30."

#### Breast Cancer soon will have no place to hide

Members of Trinity Health's mammography team are counting the days until they're ready to unveil the latest innovation in breast imaging technology. Trinity Health soon will introduce Wide-Angle True Breast Tomosynthesis – the most up-to-date 3-dimensional breast imaging system on the market.

Radiologist and Breast Imaging Section Chief Edward Hanjani, MD, says the Siemens 3D system features wide-angle image acquisition that lets physicians detect breast cancer with amazing precision – even in cases of dense breast or overlapping tissue.

"The unique feature of True Breast Tomosynthesis is the wide angle that creates a 3D picture by capturing 25 images of the breast from many angles in a wide 50-degree arc," Dr. Hanjani explained. "The images are assembled into a 3D study of the breast so we can see the breast tissue layer by layer in fine detail."

Clinical data demonstrates that the addition of 3D digital breast tomosynthesis increases detection of breast tumors. Primary advantages are fewer call backs and less anxiety for patients. Radiologists can rule out abnormalities that might otherwise be deemed suspicious, thus reducing the need for additional testing, which can be worrisome to patients.

"We expect it to reduce the number of false positives by as much as 30%," Radiologist Scott Lewis, MD, noted. "These are cases where we see a spot, call the patient back and then see that it was nothing. It should also lower costs by reducing the need for further testing."

While 2-dimensional digital mammography continues to be an excellent technology for many women, radiologists have long dealt with the phenomenon of dense breast tissue, especially in younger women, which can present a greater challenge when it comes to detecting small tumors. Dr. Hanjani says the 3D tomosynthesis technology gives doctors greater ability to detect and diagnose very small tumors as well as target the size, shape and location of tumors overall. That's because the wide-angle, multiple-image picture gives a comprehensive 3-dimensional view. Radiologists can scroll through the "slices" looking for abnormalities.

Although the 3D breast imaging revolution has been around for a number of months, Trinity specialists feel good about sitting tight and waiting for the preferred Siemens system. It has received



high marks from Trinity's radiologists as well as visiting doctors who have used it. As Dr. Hanjani put it, "The imaging looks more natural – more comparable to actual breast tissue, which makes it easier to see detail."

Lead Mammographer Connie Busch says the 3D system will offer essentially the same mammography experience as the 2D, adding, "Early detection is the key to surviving breast cancer. When we find tumors earlier, we're better able to create treatment plans that are more effective. We think this technology can help us save lives."

The role of the patient, of course, is to pick up the phone. A woman's very best defense against breast cancer is early detection and early diagnosis – both made possible through an annual screening mammogram.

While Trinity Health has installed its 3D True Breast Tomosynthesis system, Radiology and mammography staff are completing special training and certification prior to offering the service publicly.

### B-52 partners with Colombian aircraft, confirms regional commitment

A B-52 Stratofortress assigned to the 5th Bomb Wing, Minot Air Force Base, embarked on a 16-hour, non-stop mission to Colombia.

During the mission to the U.S. Southern Command (USSOUTHCOM) area of responsibility, which was closely coordinated with the Colombian Ministry of National Defense, the aircraft will join up with aircraft from the Colombian Air Force to practice common aerial tactics and procedures before conducting a flyover demonstration at the Feria Aeronautica Internacional Rionegro (F-AIR) Colombia 2015 International Air Show.

"USSTRATCOM aircraft regularly conduct training with and in support of the Geographic Combatant Commands (GCCs), our Allies and regional partners around the world," said Adm. Cecil D. Haney, U.S. Strategic Command commander. "The aircraft's participation in this airshow and the training conducted alongside our Colombian partners allow our strategic aircrews to maintain a high state of readiness and crew proficiency."

According to Gen. John F. Kelly, USSOUTH-COM commander, the flight also demonstrates the U.S. commitment to regional security and the recognition of Colombia as a key regional partner.

"Our support to Colombia is based on more than just a shared history; it is based on Colombia's enduring importance to our national security. Training missions such as these ensure effective cooperation between our countries," said Kelly.

This is not the first time a B-52 has flown to or conducted partnered training in the Central American, South American or Caribbean regions. A B-52 participated in USSOUTHCOM's annual Exercise PANAMAX in August 2014. The U.S. also participated at the F-AIR Colombia International Air Show twice in the past decade, with participation of a B-52 in 2006 and a B-1B Lancer in 2008.

USSTRATCOM is one of nine DoD unified combatant commands and is charged with strategic deterrence; space operations; cyberspace operations; joint electronic warfare; global strike; missile defense; intelligence, surveillance and reconnaissance; combating weapons of mass destruction; and analysis and targeting.
