Council election set for June 13

A special city election has been set for Tuesday June 13. This election is necessary because of the vote to change the size of the City Council in June of 2016.

Voters will elect six candidates to replace the existing 14-member council. The top three vote-getters will serve three years, until June 2020. The next three highest vote-getters will serve one year, until June 2018. Going forward from the 2018 and 2020 elections, council members will serve four-year terms, with half the six members elected every two years.

Mayor Chuck Barney will complete his term,

which ends in June 2018. The mayor position will become a voting member of the council.

Council members running again are Shannon Straight from Ward 1; Stephan Podrygula from Ward 3; David Shomento from Ward 4; Shaun Sipma from Ward 5; Mark Jantzer from Ward 6; and Lisa Olson and Kenton Kossan from Ward 7. Edward Montez and Josh Wolsky, both newcomers to the process, round out the contenders. As a result, nine candidates are running for six seats.

Road construction projects get underway in City

Construction projects are kicking it into gear this May in the City of Minot. Over twenty projects are breaking ground in 2017 and several on major thoroughfares.

On Broadway, the demolition of the Broadway Bridge continues. This two-year reconstruction project is a shared project with the North Dakota Department of Transportation and the City of Minot. This year, the efforts will be on the east bridge. After the demolition of the 50-year- old structure crews will erect a new bridge. Meanwhile, traffic is reduced to head-to- head lanes on the west bridge and access to Central Avenue can be found by using Second Avenue. Completion of the first year isn't expected until this fall.

With the Broadway Bridge comes two more shared projects between the state and city. Residents see that work west of Minot on the Highway 83 bypass and on East Burdick. The two-year expansion of the bypass began in April. This project will be converting the two-lane highway system to a wide five lane system, allowing for passing and turning lanes. The majority of work will be to the west of the current roadway and impact to travelers will be limited.

It's a different story on Burdick Expressway where work will begin in late May. The now winding road will be straightened east of the viaduct and will detour through traffic onto Valley Street. This construction will impact access to anything to the east for several months, including the North Dakota State Fair and the Norsk Høstfest along with all other events or businesses on east Burdick. Motorists are urged to allow for more time to navigate through the detour when work begins.

As Burdick Expressway experiences a closure, Minot's Downtown remains

open. The third and final phase of the Downtown Infrastructure Improvement project is also underway in the Magic City. This final phase will have less impacted intersections than the two prior but still poise a few obstacles for shoppers and residents. Throughout the Summer work will progress on Third Avenue Southeast and First Street Southwest. Clear access points are available on Second Avenue or Burdick via Broadway or Third Street. Access to Mina street can be found on Central avenue by way of Third street.

The City of Minot will also be undertaking several sewer, water and street light improvement projects throughout the summer. You may find additional information at minotnd.org.

Construction on Phase 3 of the Downtown improvements underway

"This is the last phase of a three-year project that is truly transforming the downtown, both below and above ground," said Lance Meyer, city engineer for the City of Minot. "And, as was true the last two years, it is important that residents know that Downtown Minot businesses will be open during construction, so please come on down."

Work to be done this year includes two blocks and one intersection of construction by Keller Paving from their 2016 contract, and 12 blocks and two intersections of construction to be done by Wagner Construction, Inc. based on a 2017 contract. U.S. 83 Broadway bridge construction begins in late March

The North Dakota Department of Transportation, in cooperation with the Federal Highway Administration and the City of Minot, is replacing the existing U.S. 83 Broadway bridge in the heart of Minot. Construction started on the project in late March, with the demolition of the east bridge. While the contractor on

the project, Lunda Construction of Wisconsin, continues finishing the demolition, they are also getting started on the new abutments and footings on the north side of the Mouse River that will support the base of the new bridge.

This is a two-year project that will cost roughly \$20 million to construct. It is

anticipated that normal north/south traffic will return to the new east bridge in October/November 2017.

Mouse River Enhanced Flood Protection Project (MREFPP):

2nd Avenue SW will be temporarily closed to install culvert

As work continues on Phase MI-2A (Perkett Ditch Improvements) of the Mouse River Enhanced Flood Protection Project (MREFPP), a road closure has been scheduled to accommodate the installation of a new box culvert under 2nd Avenue SW. Beginning Thursday, April 20th, 2nd Avenue SW from Westfield Circle to 24th Street SW will be closed to through traffic. A detour will be in place to route traffic along 18th Street SW to West Central Avenue and over to 25th Street SW. Residents in the area will have local access to their prop-

erty. The roadway is scheduled to reopen in mid June. This phase of the MREFPP focuses on interior drainage improvements to manage the storm water runoff on the dry side of the proposed levees. The project scope includes improvements to the existing Perkett Ditch, storm sewer upgrades within 2nd Ave SW, and the construction of a regional detention/retention pond, which was substantially completed last year. Safety is always a priority so please be vigilant near the construction zone. Leach Park is intended to remain open

Legislature approves \$193 million for flood protection projects

The City of Minot's flood protection efforts received a significant funding boost this week, as the North Dakota Legislature on Wednesday gave final approval to legislation providing \$193 million for flood control projects within the city.

"It's incredible to have this funding secured," said City of Minot City Manager Tom Barry. "With this bill, the future of flood control in Minot is significantly more clear."

House Bill 1020 provides the City with a measure of clarity as construction on the initial three phases of the Mouse River Enhanced Flood Protection Project is expected to begin this fall.

The \$193 million will fund the state's portion of the first four phases of Minot's flood protection plan through 2025 and the tieback levees needed. The estimated total cost for the initial four phases is \$324.8 million; the City of Minot's share is an estimated \$131.8 million. The first four phases, along with the tieback levees, would protect approximately 60 percent of at-risk properties which will be in the new Federal Emergency Management Agency flood plain when

the Flood Insurance Rate Maps become active in the city.

As part of the legislation, the Souris River Joint Board and the City of Minot would not be able to request more flood protection funding until the 2025 legislative session for work in the City limits.

The first four phases of the Minot flood protection plan include:

-Phase 1. The 4th Avenue project is located between just west of Broadway and just east of Third Street NE. The project includes floodwalls, earthen levees, a large pump station and other features. This phase is designed to protect a portion of northeast Minot.

-Phase 2. The Napa Valley portion of the project begins at the west edge of Minot at the Highway 83 Bypass and ends at 16th Street SW on the north side of the river near the Minot Water Treatment Plant. This portion is mostly earthen levees and includes a road closure to protect portions of southwest Minot.

-Phase 3. The Forest Road project will provide improvements near the Souris Valley Golf Course, and will protect a portion of southwest Minot.

-Phase 4. The Maple Diversion will redirect water in instances of a flood threat, and will protect a large portion of northwest Minot.

Tieback levees on the east and west ends of Phase 1 and Phase 2 will tie the flood protection into high ground.

The bill now goes to Gov. Doug Burgum for his signature. The bill passed through conference committee on Tuesday, and was approved by members of the House of Representatives later that day. The Senate approved the bill on Wednesday.

"Thanks to our state and city leaders, Minot is well on its way to being a more resilient community. These first four phases will help alleviate a lot of stress and burden from so many of our citizens. There isn't a price tag you can really put on that sense of security," said Barry.

City of Minot housing assessments: more options, lower valuations

Citizens in Minot now have more housing options under the \$200,000 level than last year, according to information from Minot City Assessor Kevin Ternes. In March 2017, there were 136 properties with assessed values under \$200,000 within the city limits, up from 94 properties last March, according to the City Assessor's 2017 Annual Report. Ternes said most Minot property owners will see a decrease in their property valuations in 2017, with total overall valuation for 2017 dropping approximately 8 percent from 2016. This year, residential valua-

tion in Minot declined roughly 5 percent from the previous year, according to an annual report prepared by the City Assessor's Office.

"This is the first time in recent years that there has been a significant decrease in overall property valuation from the prior year," Ternes said. "We saw a slight reduction in the residential and commercial market selling prices in 2016, and that has contributed to the decline in property valuations."

Minot's typical 2017 commercial valuation decreased approximately 6 percent

from last year. The valuation of motels and apartments has decreased between 20 percent and 30 percent, according to figures prepared by the assessor's office. The annual report from the Assessor's Office was presented at the Board of Equalization meeting April 11 at City Council Chambers in City Hall. Yates-Northwest Employed to manage Trinity Health hospital project

Yates-Northwest Contracting, a joint venture, has been selected to manage the project's next step – evaluating and refining materials and cost estimates to bring them in line with the project's targeted budget.

Trinity Health Facilities Vice President Dave Kohlman said Yates is one of the top construction providers in the nation and has already engaged with architects and planners to present construction estimates that will be used to engage the construction team.

"It's been a smooth transition," Kohlman says. "The design of the hospital and medical office building continues to be refined to accommodate the services that will be housed on the campus within the project's scope. We anticipate more tweaks as we adapt to changes in the costs of labor and materials, and find ways to improve the flow of patients and care throughout the system."

He said one design change put forward by TEG Architects, the project's designers, is to possibly re-position the medical office building in relation to the hospital to significantly reduce the amount of concrete needed. "The MOB was slated to be positioned alongside the hospital, running parallel, which resulted in a more expensive design. Instead, our design places the MOB perpendicular with the hospital, saving millions of dollars in costs while gaining more natural light into the adjacent hospital facility."

In the meantime, work has been steady on the project throughout the winter months, and site preparations will continue, with an official groundbreaking planned for this summer. Other project milestones, such as financing and approval by the North Dakota Department of Health, are also proceeding on schedule.

Trinity Health President and CEO, John M. Kutch, said the goal is to ensure future generations have convenient access to the highest quality of care close to home. "The excitement for this project continues to grow within our organization and throughout our entire service area, as we all recognize its significance for our patients, families, employees and communities," he said.

Plans call for a \$275 million facility

with a construction site covering 76 acres and featuring ample parking for patients, visitors and staff. The project is expected to be completed in early 2020.

Reynolds said the City collected approximately 14,000 pounds of e-waste in 2016 during the two-day program, along with about 9,000 pounds of other items. 
