

ACCRA third quarter cost of living compares local costs to nationwide costs

Minot's cost of living measured 3.1% higher than the national average for the third quarter of 2018 (U.S. Average Composite Index = 100%) The cost of living index is published by the American Chamber of Commerce Researchers Association (ACCRA). The ACCRA Cost of Living Index measures differences between areas in the cost of consumer goods and services, excluding taxes and non-consumer expenditures. It is based on 100,000 data points, for which prices are collected quarterly by the Minot Area Chamber of Commerce and 288 other urban areas across the nation.

CLI graduates raise funds for kids in need

The 2018 Community Leadership Class ended with a bang. That's because they made a huge impact on the community by providing nearly \$10,000 in cash and items to the Essentials for Learning project. Essentials for Learning is a program started by a group of Minot State University students in the Roger Looyenga Leadership Development Program. Their mission is to help students with their most basic needs in the Minot Public School System. CLI participants gathered deodorant, toothpaste,



soap, socks, laundry soap and more to help students in need concentrate on their education. Way to go class of 2018!

CLI is a nine-week course offered through the Minot Area Chamber of Commerce to acquaint 25 participants with what Minot has to offer. The class is capped at 25 and there are 23 people already signed up for the 2019 class. Get your name in now if you would like to secure a spot.

City launches environmental review step for gathering place

The City of Minot is in the final stages of completing the environmental review process for the proposed downtown gathering place project.

Mayor Shaun Sipma has signed the required Finding of No Significant Impact (FONSI), which shows that no environmental related obstacles were identified during an assessment of the pro- posed site.

A mandatory 15-day waiting period for public comment began Nov. 7 with a published legal notice. After the waiting period, the environmental review will be immediately sent to the Denver Regional Office of the U.S. Department of Housing and Urban Development (HUD). The final steps require HUD approval and issuance of a "Release of Funds" notice

to the City. Once that notice is received, the City can proceed with offers to purchase property.

"The City has worked to expedite the environmental review for this project and to meet our own deadline of submitting the completed review to HUD in mid-November," Sipma said. "We're pleased that this project continues to make progress."

The National Environmental Protection Act, which governs all federal grant funds, stipulates that no project or activity can begin until an environmental review is completed and approved by the federal department or agency administering the grant.

"We're looking forward to taking the next steps to make this project a reality as soon as possible," City Manager Tom Barry said. "We've proven that we are committed to this project, and we continue to work closely with HUD to accomplish our goal of bringing a new gathering place to downtown Minot."

John Zakian, disaster resilience grant program manager for the City of Minot, said he expects HUD to approve the environmental review fairly quickly. He said the City will be prepared to send out offers to property owners in the gathering place site footprint as soon as HUD approves the review.


