## Candidate forums well attended

The Minot Park Board, School Board, City Council and Mayoral Candidates were featured in the forums. #### **Election set for June 12**

The June Primary Election is set for Tuesday, June 12. Minot voters can go to Room 201 of the Minot Municipal Auditorium to cast their vote for five seats up for re-election. They are mayor, three council seats and municipal judge. Those running for Mayor are Nancy Bommelman, Timothy Mihalick and Shaun Sipma. There are six people running for the three seats on the Minot City Council. They are: Mark Jantzer (incumbent), Lisa Olson (incumbent), Edward Montez, Paul

Pitner, Stephan Podrygula (incumbent), and David Shomento. As for the Minot Municipal Judge, Ashley Beall and current Judge Mark Rasmuson are running. Polls are open from 7 a.m. until 7 p.m. June 12 at the Minot Municipal Auditorium.

### Task Force 21 connects with congressional leadership

Two members of Task Force 21 were in Washington, DC, on May 10 to support a presentation by Senator



Heidi Heitkamp on the nuclear triad. This was an important conversation that addressed modernization of the weapon systems. Additionally, it was stressed that all involved needed to help take the modernization story to the general public. More than 60 individuals attended, including embassy personnel from several allies.

## Strengthen ND to host rural design workshop later this year

The Citizens' Institute on Rural Design™ (CIRD), an initiative of the National Endowment for the Arts managed by Project for Public Spaces, announced today that Strengthen ND was selected to host a rural design technical workshop later this year.

The workshops will bring together local leaders, non-profits, community organizations, and citizens with a team of rural planning and creative placemaking professionals to craft actionable solutions to their communities' development and design challenges.

The proposal submitted by Strengthen ND to utilize the opportunity to support their work in Tuttle, ND was one of four selected by an advisory panel from a competitive applicant pool this year. CIRD awardees receive a \$10,000 stipend to support the workshop and follow-up planning sessions. Each community also receives in-kind design expertise and technical assistance valued at \$35,000, and additional support through webinars and web-based resources on www.rural-design.org.

"It is exciting to witness the bold vision that Tuttle has for its future," said NEA Director of Design and Creative Placemaking Jen Hughes. "Design is an important tool to spark economic revitalization and bring new attention to local amenities. We're thrilled to support this CIRD workshop and deliver design expertise that will ultimately impact the quality of life for rural residents."

"This year's technical assistance focus areas - Main Street Revitalization, Healthy Living by Design, and Multi-Modal Transportation - reflect key overlapping issues facing rural communities across the country and provide a great opportunity for sharing hands on practices and applicable lessons learned across multiple sectors" said Cynthia Nikitin, CIRD Program Director and Senior Vice President of Project for Public Spaces, Inc.

Strengthen ND is supporting the community of Tuttle to develop plans for a new multi-use community space and economic engine, the Tuttle Rural Innovation Center (TRIC). The workshop will devel-

op design plans for the new innovation center featuring a small business and art space incubator, a commercial kitchen, event space, and a maker space for local artisans and crafters. The center has the potential to be an example of successful adaptive reuse, sparking a renaissance along Main Street. This project leverages community momentum in establishing a community-owned and volunteer-operated grocery store. Workshop partners include Tuttle Rural Innovation Center, U.S. Department of Agriculture Rural Development - North Dakota, North Dakota Local Foods Development Alliance, and Tuttle Betterment Club.

"We are so excited for the opportunity to host a CIRD workshop," remarked Megan Laudenschlager, Executive Director of Strengthen ND. "Not only will this workshop directly support our work in Tuttle, but it will also help us distill CIRD's philosophy and tools to our partners statewide."

### Infrared Pothole Repair: A durable solution that fits your budget

Each year after the snow melts, property managers and homeowners should inspect the condition of their asphalt driveways and parking lots. As asphalt ages, potholes are inevitable.

#### How do potholes form?

important aspect in treating potholes is understanding the factors that cause them. Activity below the surface initiates asphalt failures. Moisture seeps into the cracks of pavement, causing the supporting soil below to weaken. Water beneath the surface freezes, which causes the ground to expand and the pavement to rise. #### What are my options?


Prevention goes a long way. Protect the asphalt base by keeping the cracks sealed with a hot pour, flexible sealant. Repair alligator cracking and potholes with infrared before they grow into massive, unsightly defects that require a paving company to fix. Infrared repairs restore the surface to an impermeable state. Small repairs are quick, affordable, and produce beautiful results.

#### How does infrared work?

A heated plate is placed over the pothole, softening the asphalt without burning it. After heating is completed, the once defective asphalt is recycled and raked back into place. Rejuvenating oil and fresh hot mix asphalt is added. The mixture is then smoothed and compacted to create a strong, seamless, thermal bond between the repaired area and the original asphalt.

## Governor takes major step to support opportunity for investment in downtown Minot

The City of Minot is one of 25 North Dakota communities approved for an Opportunity Zone as part of a new tax incentive program through the U.S. Department of Treasury.

Minot's Opportunity Zone includes the downtown business district.

This new tax incentive will allow investments for economic development activities to earn capital gains tax exemptions from the federal government to boost financing of commercial and business activities in the designation zone. Opportunity Zones are an investment initiative contained in the 2017 Tax Reform Act passed by Congress and signed by the President Donald Trump in December 2017.

Minot Mayor Chuck Barney praised Gov. Doug Burgum for including the city's downtown census tract as one of the 25 census tracts allowed for submission

"This can be significant for Minot and we're pleased the governor included downtown Minot as a designation," said Barney. "This may help develop a coordinated and sustainable strategy to encourage economic growth and business development in the downtown area."

The new federal law allows each governor to nominate a fixed number of census tracts. Upon review by the U.S. Department of Treasury of the nominated census tracts, the nominated areas are approved as Opportunity Zones.

Minot City Manager Tom Barry noted that the downtown census tract contains the state Renaissance Zone. Combining the Renaissance Zone with the Opportunity Zone designation will present the city with solid market opportunities to induce additional investment.

"It's a double positive," said Barry. "Between the two zoning incentives, the City of Minot could really see great impacts."

Barney added that the Opportunity Zone designation for Minot will also provide added motivation to support and take advantage of the governor's Main Street initiative.

John Zakian, the City's Disaster Resilience Grant Program manager, said with the capital gains tax breaks, the Opportunity Zone should encourage leverage investment from the private sector in federal grant projects in downtown, including the planned Gathering Place as well as rehabilitation of multi-family housing.

The Treasury Department is expected to post the rules and regulations governing Opportunity Zones and the benefits in the Federal Register in June.
