Showcase of Business set for Nov. 14



Minot Area Community Foundation announces Challenge Grant

The Minot Area Community Foundation (MACF) announces the 3rd Annual Donation Station Challenge Grant to benefit Minot food pantries. Area organizations are invited to use the Donation Station in the coming months to collect items and stock area food pantries for a chance to win additional grant dollars for one of the eligible Minot food pantries.

This is the third year that MACF is offering the challenge grant. Last year, 11 organizations participated, collecting over 16,000 pounds of food. A total of \$5,500 in grant money was distributed because of the challenge grant's success.

This year's challenge grant will run from Sept. 1 through Dec. 31, 2019. Food collection events must take place within this time frame, and The Donation Station must be utilized for the event. Eligible Minot food pantries include Our Lady of Grace, The Lord's Cupboard, and the Salvation Army. Rural communities want-

ing to participate will be evaluated on a case by case basis.


